"Justice and only justice you shall pursue..." by Barbara Buzzard

How then is it possible that 64,443, 118 babies' have been killed since 1973 via abortion?

And just in case you might think all is well since the Roe Vs Wade ruling, granted that thousands of lives have been saved: yes, the abortion landscape has changed. But Planned Parenthood and other abortion cartels are on a rampage, launching massive campaigns to open abortion supercenters that could double or triple that business. Planned Parenthood's doors are still open and mothers are still walking through those doors. Their children however, do not make it out alive. Currently 900,000 babies are killed every year. It is always good to remind ourselves exactly what abortion actually is: it is the unnecessary and intentional killing of an unborn child. To use a court term -willful killing. If abortion is healthcare – why is it lethal to the child?

The Big Abortion cartel is doing everything it possibly can to keep the carnage happening. Not only are we being forced to pay for it but forced to pay for abortion travel. Do we really think that Big Abortion will stop killing babies when it is Big Business?

Abortion giant Planned Parenthood received \$286 million for killing 383,00 babies.

An equal rights amendment is being pushed that would legalize abortion up to birth, enshrining abortion on demand until birth. This, of course, is the OPPOSITE of equal rights.

The manipulation of language is a huge factor used by those promoting killing to reframe our former thinking that "life is sacred" into "abortion is a sacred act."

As Christians – we celebrate life, not death.

One of our political leaders who seems to celebrate abortion says that women need (the right) to kill their babies in order to be successful. Pope Benedictus XVI condemned abortion as an "intrinsic evil." Although RvW was remarkably and incredibly flawed and unconstitutional from its inception, some want to make it the law of the land once again. This is in spite of the fact that 69% of Americans want abortions limited or banned.

One of the most honest 'after abortion' descriptions is from the individual who says, "I hate myself every day. I just want this to be over. I am just so broken." When you leave that abortion facility – you are still a mother but the mother of a dead baby.

It is noteworthy that of the 7 who died in the recent Hamburg, Germany massacre of Jehovah's Witnesses, one was an unborn child. There was no question of this child not being counted as a human. The law stated that the unborn baby was a person.

We are told that Abortion Grief is very very real – a well known singer spoke of the "train of trauma" following her abortion which she deeply regrets. She found it painful beyond measure and warns that "you will regret it your whole life." Thousands of mothers agree and as another mother wrote – you always have a little 'ghost' hovering in your conscience, stealing your happiness.

On the subject of Abortion Grief, this is Martin Iles, Australian Director of 'The Truth of it.' (Episode 19 – 16:44-18:57)

I hope we are all aware of the 2 individuals in England who were arrested recently for praying SILENTLY outside an abortion clinic. After trial the charges were dropped but the arrests sent an ominous message: I think it was this: you can be fined for the contents of your mind. And then in this country the case of Mark Houck, father of 7 who was arrested by between 20 to 30 armed men in front of his children. Mark's young son while praying & singing outside an abortion clinic had been harassed by an abortion activist and his father pushed the man away. He was declared innocent of any charge but later at his home was arrested.

While most states do not keep track of the # who survive abortion, reports found that 34 babies were born alive in botched abortions between '20 and '22 in just 7 states (LifeNews 12:30:22). These are babies who were considered small enough to just pull them out with forceps rather than dismembering them piece by piece as is done in later abortions. The 1st thing most people express is shock – if the baby is born alive – i.e. a failed abortion – how could you kill it if it survives? And how could that be legal? A number of states do allow this and it is currently happening – yes, on our watch. The horror of this invades and perverts our thinking: since we can kill them IN the womb – why not outside? (We are unlike any other country in this - we are most similar to N. Korea.)

A UN plan to promote abortion worldwide failed recently when twenty-two pro-life nations objected. (LifeNews, 4/18/23)

Apr. 14 was the one year anniversary of the finding of 115 aborted babies in WA, DC, 5 of whom were full term. They were found in a medical waste bag. Could there be any doubt that our world is oppressed by dark forces?

35 states are suing the FDA with regard to the dispensing of chemical abortion drugs.

I understand that if one is "losing it" spiritually – one of the most devastating losses is the capacity to judge, and of course this could apply corporately to organizations and to churches. One of the judgments God pronounces against us is that we failed to discern or judge justly. When the court convenes – as Scripture promises it will – may we be found to judge justly! We are warned several times in Scripture not to justify the wicked; if we align ourselves with them (and we can do this by silence) we are as guilty as they are.

The scourge continues as many abortion industries try to get 911 calls not to call attention to them by not using sirens and lights when transporting emergencies from the abortion facility to a hospital.

The scourge continues as death can now be dispensed at the corner drugstore with the drug, Mifepristone which the Supreme Court is ruling on.

We must not shrink from the enormity of this baby killing, nor from the absolute horror of it. The true measure of our character is revealed in the way we treat others; in this case – those unborn babies condemned to a brutal killing. Doesn't the love of mercy dictate for us – active resistance?

It is possible for silence to corrode the soul. Just as abortion sucks the life out of those tiny bodies – it also sucks the life out of our souls if we approve it and unless we stand against it.

Silence is motivated by fear. Fear is a hindrance to justice; it can infect us as Christians and make us blind to the horrors going on around us. If we want justice and mercy for the unborn – we will have to say so.

The judgments we make should be dependent on Scripture because Scripture makes the final call on morality and Truth. We are to "hate evil and love good." (Amos 5:15) How will our nation survive without Christians being salt and light – i.e. hating evil and loving good?

As the deer pants for the forest...so should our hearts long for justice for the unborn. Can't we think a bit more like God does? One of the most tragic things one could ever see is a group of women marching for the right to kill their child.

Our marching orders are these: "Seek justice, rescue the oppressed, defend the orphan." (Isa. 1:17b)

"...What does the LORD require of you but to do justice, and to love kindness." (Micah 6:8b)

As must always be said: there is no condemnation, pending repentance – of any involvement in abortion. God's grace is entirely sufficient. Every state has Safe Haven laws and there are myriad organizations providing help to prospective mothers in need, with a view to loving them both.

I submit to you that putting on the mind of Christ makes abortion unthinkable.
